## **Notice of Public Hearing on Tax Increase**

A tax rate of \$ 0.10 per \$100 valuation has been proposed by the governing body of **Harris County Emergency Services District No. 17.** 

PROPOSED TAX RATE	\$0.100000 per \$100
NO-NEW-REVENUE TAX RATE	\$0.092345 per \$100

The no-new-revenue tax rate is the tax rate for the 2020 tax year that will raise the same amount of property tax revenue for **Harris County Emergency Services District No. 17** from the same properties in both the 2019 tax year and the 2020 tax year.

The voter-approval rate is the highest tax rate that **Harris County Emergency Services District No. 17** may adopt without holding an election to seek voter approval of the rate, unless the de minimis rate for **Harris County Emergency Services District No. 17** exceeds the voter-approval rate for **Harris County Emergency Services District No. 17**.

The de minimis rate is the rate equal to the sum of the no-new-revenue maintenance and operations rate for **Harris County Emergency Services District No. 17**, the rate that will raise \$500,000, and the current debt rate for **Harris County Emergency Services District No. 17**.

The proposed tax rate is greater than the voter-approval tax rate and the de minimis rate. If **Harris County Emergency Services District No. 17** adopts the proposed tax rate, **Harris County Emergency Services District No. 17** is required to hold an election so that the voters may accept or reject the proposed rate. If a majority of the voters reject the proposed tax rate, the tax rate of the **Harris County Emergency Services District No. 17** will be the voter-approval rate of the **Harris County Emergency Services District No. 17** 

A **PUBLIC HEARING** ON THE PROPOSED TAX RATE WILL BE HELD ON August 24, 2020 at 9:30 a.m., at Administration Building, 10410 Airline Drive, Houston, Texas 77037.

Harris County Emergency Services District No. 17 may take action on the proposed tax rate on August 24, 2020 at 9:30 a.m., following the hearing to be held.

The 86<sup>th</sup> Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.
