

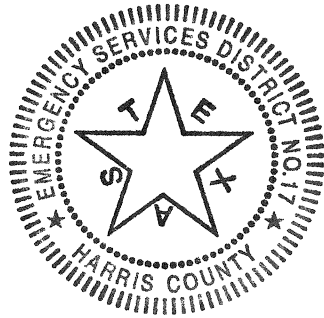
NOTICE OF PUBLIC MEETING

10. To receive a report from Fire Chief on Fire Department activity.
11. To review, discuss and act on any issues related to the repairs, improvement, utilities, permits and construction of District facilities, including engaging construction services, change orders and construction payments.
12. To review and act on personnel matters, including action on hiring, retention, policies, duties, and benefits.
13. To review and act on real estate, including but not limited to purchase, sale, platting, or permits.
14. To review and act on any matters regarding dispatch, communications or mutual aid agreements with other agencies.

To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel regarding pending or contemplated litigation, settlement offers or on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas and Tax Code §323.3022 to discuss sales tax matters.
16. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
17. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.

18. To review, discuss and act regarding matters discussed in the Closed Session.
19. To set the date of the next regular meeting.
