

Notice of Public Hearing on Tax Increase

A tax rate of \$0.10 per \$100 valuation has been proposed by the governing body of **Harris County Emergency Services District No. 17**.

PROPOSED TAX RATE	\$0.100000 per \$100
NO-NEW-REVENUE TAX RATE	\$0.077464 per \$100
VOTER-APPROVAL TAX RATE	\$0.080379 per \$100
DE MINIMIS RATE	\$0.083846 per \$100

The no-new-revenue tax rate is the tax rate for the 2023 tax year that will raise the same amount of property tax revenue for **Harris County Emergency Services District No. 17** from the same properties in both the 2022 tax year and the 2023 tax year.

The voter-approval rate is the highest tax rate that **Harris County Emergency Services District No. 17** may adopt without holding an election to seek voter approval of the rate, unless the de minimis rate for **Harris County Emergency Services District No. 17** exceeds the voter-approval rate for **Harris County Emergency Services District No. 17**.

The de minimis rate is the rate equal to the sum of the no-new-revenue maintenance and operations rate for **Harris County Emergency Services District No. 17**, the rate that will raise \$500,000, and the current debt rate for **Harris County Emergency Services District No. 17**.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that **Harris County Emergency Services District No. 17** is proposing to increase property taxes for the 2023 tax year.

The proposed tax rate is also greater than the voter-approval tax rate and the de minimis rate. If **Harris County Emergency Services District No. 17** adopts the proposed tax rate, **Harris County Emergency Services District No. 17** is required to hold an election so that the voters may accept or reject the proposed rate. If a majority of the voters reject the proposed tax rate, the tax rate of the **Harris County Emergency Services District No. 17** will be the voter-approval rate of the **Harris County Emergency Services District No. 17**.

A **PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 23, 2023 at 9:30 a.m.**, at Administration Building, 10410 Airline Dr., Houston, Texas, 77037.

Harris County Emergency Services District No. 17 may take action on the proposed tax rate on August 23, 2023 at 9:30 a.m., following the hearing to be held.

The election will be on November 7, 2023. You may contact the Harris County Clerk's Office – Election Department for information about voting locations. The hours of voting on election day are 7:00 a.m. to 7:00 p.m.

YOUR TAXES OWED UNDER ANY OF THE TAX RATES
MENTIONED ABOVE CAN BE CALCULATED AS FOLLOWS:

$$\text{Property tax amount} = (\text{tax rate}) \times (\text{taxable value of your property})/100$$

The 86th Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by **Harris County Emergency Services District No. 17** last year to the taxes proposed to be imposed on the average residence homestead by **Harris County Emergency Services District No. 17** this year.
