13. To review and act on any matters regarding dispatch, communications or mutual aid agreements with other agencies.

To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel regarding pending or contemplated litigation, settlement offers or on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas and Tax Code §323.3022 to discuss sales tax matters.
15. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
16. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.
17. To review, discuss and act regarding matters discussed in the Closed Session.
18. To review and discuss matters related to the District's 2025 Tax Setting process.
